GUIDELINES FOR FUNDING REQUESTS

The primary objective of the Foundation is the raising of funds through private and public donations in order to fund outreach programs and under certain conditions, major maintenance of St. David's buildings or properties, as outlined herein.

The income from capital and properties of the Foundation shall be utilized for the following purposes at such times as the Directors may determine or upon receipt of an acceptable request directed through the Church Council.

- 1. OUTREACH PRIMARILY WITHIN THE CITY OF CALGARY, including ministerial education, new programs within the Church, leadership training, conferences on major issues of concern, creative programming in Christian education, to support new congregational development in Calgary, and to reachout into the broader community with Christian undertakings as funds are available.
- 2. MAJOR MAINTENANCE TO THE BUILDINGS AND PROPERTIES OF THE CHURCH. Major maintenance means any expenditure in excess of \$5,000 needed to maintain the building and properties of the church in good working order.

Foundation funding of the Church is not intended to replace the open collection and envelope giving of the Church Members. Accordingly, Foundation funding shall not be used for such items as staff salaries, normal operating expense taxes, utilities and similar items that are incurred by the church on an ongoing regular monthly basis, or for capital renovations.

It is the intention that the capital raised by the Foundation shall continue to grow however it is to be maintained at a minimum level of \$100,000. Eighty percent of earned annual income will be disbursed each year.

The Foundation is desirous of providing seed money to assist in new programs being started. Priority will be given to those programs that benefit the maximum number of persons.

Ideally the request for funding should be submitted three months in advance to allow for processing through the Council and the Foundation. New long-term programs may receive seed funding for up to three consecutive years when they should be self-sufficient.

In order to maintain the profile of the Foundation, the Foundation's sponsorship should be recognized in any printed brochures and at the actual events.
