1. Bishop's Remarks

2. Vision Reflection/Bible Study

Canon Dawna Wall led the Council through a reflection focusing on The Mercy of Care and Maintenance (Isaiah 50.4 and Psalm 127) and used a poem called Atlas by Ursula Fanthorpe from Safe as Houses. Feedback was received from the members of council.

3. Living the Vision #1

a) Community of Learning and Lay Training

Canon Wayne Stewart, Canon Jeanette Muzio and David Buckman spoke to this diocesan programme. The information was presented as a Power Point which will be downloaded into Drop Box so everyone will have access to it. The Community of Learning and Lay Training is meant to supplement other programmes already instituted in the diocese. This programme comes out of our Diocesan Vision under Lay Ministry and Leadership.

c) Correspondence

The Bishop received a letter from Bishop Rob Hardwick, Diocese of Qu'Appelle requesting support for his cross-Canada Bike Tour, praying, as he rides, for unity, healing and reconciliation. He arrives in Victoria on May 18th, will dip the wheels of his bicycle in the Pacific and then ride to Nanaimo and ride the ferry to North Vancouver. Funds raised on this endeavor would be used to support the Anglican Church of Canada Indigenous Ministry to assist in their programme, training and support ministries especially as they continue a journey to explore a self-determining church within the Anglican Church of Canada. (The letter is in Drop Box). There was conversation as to whether the council would agree to fundraising while Bp Hardwick is on the Island. This will be discussed again at the next council meeting when everyone has had a chance to read the letter. One question that was asked was would other diocese be supporting this ride. The Bishop will check with other dioceses.

d) Business Arising No business arising.

e) Synod 2018

The Bishop told the Council that at this point we are not ready to have Synod in April. The Case for Support for a financial campaign has not been yet been prepared. The diocese has engaged a consultant to work with Brian Evans our Stewardship Officer to construct a clearly articulated case for support and also to have some time for Brian to meet with parishes and people in the diocese (not necessarily members of our parishes) in order to establish financial support for our diocesan financial campaign.

- > There needs to be very good messaging regarding why the date has changed
 - We are on a journey of building trust across the diocese and need to be open and honest
 - We are building relationships
 - We need more time to do this right.
- The message needs to be clear -- we are postponing synod to make time for more conversation and discussion about the needs and desires of the diocese as we move forward. There was a healthy discussion at the Nimpkish Regional meeting with both conversation and listening happening.
- The future dates of the We Together Conference needs to be included in the messaging (We Together would have happened September 28th and 29th)
- > The work plan for March through June needs to dovetail with the new dates.
- The Bishop will think about how to involve the newly elected regional representatives to Diocesan Council and they will be informed.

6. Living the Vision #2

a) Financial Campaign and Case Statement

Gail Gauthier spoke to a Power Point presentation of the narrative budget for 2018. This included a projected (estimated) budget for the years 2019-2023 with numbers with fundraising and numbers without fundraising.

Brian Evans spoke to the Financial Campaign and the Case for support. The Financial planning team has met with the consultant. The longer timeline to Synod is helpful but the momentum must be maintained. Brian will meet with the Bishop to discuss the way forward to begin the fundraising process. There has been conversation with Susan Graham Walker the Stewardship Officer for the National Church. Planned giving needs to be part of the presentation.

7. Faith in Foundation #3

Bishop McMenamie told the members of Council that Tony Davis was no longer a member of Council or Finance committee because he was now a staff member with responsibility for the Refugee Sponsorship Programme for the Upper Island.
