## c) Vision Fund Jury

Canon Ian Alexander gave the members of Council an update on the Vision Fund grants process. At this point in time there are 34 open files requesting funds. The criteria are evolving -

- ➤ the fund shares the funds 50/50 with the requesting parish. If a parish cannot afford to pay 50% for the project there is some flexibility on the part of the Vision Fund. It will consider a contract position.
- > the Vision Fund does not pay ongoing salary requests but top up support of staff if it relates to the project
- if the project is looking for funds to purchase equipment which is necessary to the success of the project, it will be considered.

The intake of project will be ongoing but there will be an ultimate deadline.

Paragraph C to read

- c. Applications for loans shall be submitted to the diocesan finance officer, giving full details of
- a) The total cost of the project;
- b) The amount available or potentially available within the parish or mission;

c) The proposed terms of repayment.

and signed by the incumbent and the churchwardens. All projects are to be undertaken as a collaboration between the diocese and the parish with involvement and responsibilities determined before the commencement of the project and may be subject to change as required through the duration of the project.

Paragraph (e) to be amended to read:

e) Repayments shall commence with the month following receipt by the borrower of the final advance of the approved loan and may be spread over a period not exceeding ten (10) years *unless an exception is granted by the diocesan council*. Such repayments....

Paragraph f be amended to read:

f) Where a borrower has not made a payment for three consecutive months, or one quarter where quarterly payments are made, or where payments are consistently delinquent for no apparent reason, the interest rate will be raised to *the prime lending rate of the banker to the diocese* as of the date of the first mission payment.....

Paragraph g should be deleted.

Paragraphs h and I would then become paragraphs g and h.
