#### 1. Welcome

The Bishop opened the meeting with prayer and then asked the members of Council to introduce themselves giving their name, their parish and either a book you are reading or the latest movie you watched.

# 2. Vision Reflection/Bible Study

Bob Gill, our Chancellor, offered the reflection for the meeting 1Samuel 16. 7-13 and Titus 1.5-9 and then asked the members of council what qualities God expects of us in discharging our duties as members of DC and what gifts or talents to we bring to Council:

## b) Acts of Synod

#### ACT OF SYNOD # 8 FIVE YEAR PLAN

## ACT OF SYNOD # 16 Single Use Plastics

#### That

1. Parishes and synod office curtail the purchase of products with single use plastics, including rigid foam (Styrofoam and other brands), and to end such purchases by 2023; and

- 2. The Task Team Engaging God's World raise awareness with the members of the diocese and also advocate on behalf of the diocese.
  - a) With manufacturers to seek and use alternatives to the use of single use plastics;
  - b) With the food industry (restaurants and grocery stores) to eliminate the use of rigid foam in their packaging and 'take out'; and
  - c) With the general public to reduce its use of single use plastics;
  - d) With government to pass regulations that will lead to the elimination of the manufacture, sale and use of single use plastics.
- 3. Diocesan Council report back to the next sitting of synod on the steps taken to effect this motion and the effectiveness of those steps.

Upon receipt of said materials, it will be the responsibility of Diocesan Council to ensure this information is communicated to parishes, and to formulate a plan for review of implementation progress in the parishes and synod office.

# Land lease - St. Paul's Housing

That the Diocesan Council approve the amendment of the land lease between the Anglican Synod of the Diocese of British Columbia and the St. Paul's Housing Society:

- Restart the land lease with St. Paul's Housing Society as a 99-year term commencing on January 1, 2019. This is conditional on St. Paul's Housing Society approval and commitment to subdivision of the land to reduce parcel size as approved in zoning; subdivision to be done when approved by the Township of Esquimalt.
- The land lease rent to be set at \$46,500 per year for the first 15 years of the term, thereafter increased by the BC Consumer Price Index for each five years of the remaining term of the land lease.

have new parish profiles in place. There will be a Vision animator and the Transforming Futures facilitator in place to work with the parishes.
