1. Welcome

The Bishop opened the meeting with prayer and shared his remarks (on file). He stated that as we prepare for the upcoming synod in September we need to clarify our language when talking about Transforming Futures, stewardship and the budget so all understand what each topic is and how it makes its own unique contribution to the life of the Diocese.

The Bishop informed the members of Council that he had appointed three new Archdeacons: The Venerable Clara Plamondon is Archdeacon of Cowichan/Malaspina, the Venerable Dr. Dawna Wall is Archdeacon of Selkirk and the Venerable Lincoln McKoen is Archdeacon of Nimpkish.

2. Vision Reflection/Bible Study

Lynn Schumacher based the reflection on the passage from Psalm 100 and offered an image of 'waiting in the hallway'. After some table discussion she ended the reflection with the Doxology.

3. Faith in Foundation #1

a) Regrets for Absence

The Secretaries noted the regrets for absence from the meeting.

b) Minutes of June 28th, 2018

c) Business Arising

Bob Gill, the Vice Chancellor is reviewing the Privacy Policy. It is on his desk.

d) Finance Committee minutes of July 19th, 2018.

Gail Gauthier, the Diocesan Finance Officer, spoke to the minutes of July 19th, 2018 and to the Finance Report. She spoke about requests to draw funds from the CTF which will be discussed in more detail later in the meeting.

Gail has received the draft investment policy for the National Church as presented at the last meeting of the Council of General Synod. This will be shared with the Diocesan Investment Committee.

e) Dawson Heights

Peter Daniel spoke to this topic. Dawson Heights is a housing provider for seniors in the Diocese. The Board of Dawson Heights wants to redevelop on a portion of the complex called 'The Cottages'. This project needs financing and are looking for the funding from BC Housing but BC Housing will not provide financing unless it is a society. The board of Dawson Heights is requesting that Diocesan Council allow them to form a new society. It was

f) 930 Mason Street

Peter Daniel presented a request from the Church of St. John the Divine, Quadra Street, to demolish a structure they own at 930 Mason Street. It was

4. Living the Vision #1

a) Overview Report on Vision Fund

Canon Ian Alexander and Julie Poskitt offered a PowerPoint presentation to show the projects and outcomes of the Vision Fund. This presentation will also be made at the Synod in September.

Clara Plamondon offered a prayer in thanksgiving for the lunch we were about to enjoy. After lunch, David Stewart offered thanks to the kitchen crew on behalf of the meeting.

5. Living the Vision #2

<u>Transforming Futures Presentation and Discussion</u>

Esther Jang, senior consultant with Global Philanthropic, offered some observations based on her interviews with parishioners and some staff. This is a diocese with people of deep faith, who feel the church needs to be involved in this program, needs to move forward, but isn't sure how. Esther recommended that fundraising resources be created for the diocese, that work should be done in close relationship with parishes, that a part-time stewardship officer be hired to be Synod's fundraising contact and to work with the Bishop, and that a culture of philanthropy and growth in fundraising be cultivated.

The case for support of the fundraising program varies from parish to parish.

Table group conversations were held around the questions

- a. What inspires you?
- b. What challenges you?
- c. What further questions do you have?

A sampling of the responses is as follows:

- a. The broad consensus of love for the church
 The Vision Team report
 Receptiveness to creativity
 The broad range of finance strategies
 This new model of philanthropy not a classic campaign
- b. The "why" is still not catching people do we need a campaign? The campaign needs to begin soon

We need to dream again

Volunteer burn-out

Aging population

Communication of this being a "modest ask" when described as a weekly donation for each participant over 5 years.

We do not yet have a strong culture of giving

c. What will the diocese do with the 40%? How does one understand the relationship between parish and diocese (trust)?

The conversations were still continuing when the time ran out. Esther made notes of the responses and commented on some. She stressed that **together** we will succeed.

7. Living the Vision #3

Five-Year Financial Plan Presentation and Discussion

Ian Alexander gave a PowerPoint presentation of the Five-Year plan (on file) including an introduction and background (How did we get here?).

The Recommended Plan is a balanced one over 5 years, including stopping the running of deficits. The Diocesan portion of the fund would be used to fund Vision priorities. The Fund supports the Diocesan Vision.

Its current target is about \$ 7 million over 5 years (7-8 years for all pledges to be received). There would be no diocesan assessment on the parish portion of the campaign.

What happens if we don't move forward with the plan? The Status Quo is NOT a Plan B. There could be a report on a mid-course correction, but it is hoped that would never be used.

That Diocesan Council recommend to Synod the recommendation of the Transforming Futures joint fund-raising initiative (with further adjustments to be made) and the recommended Five-Year Financial Plan as presented.

That in the light of the Council of General Synod investment policy, a further meeting between St. Barnabas and delegates from the Finance Committee be held before a decision is made about the request from St. Barnabas to withdraw funds from the Consolidated Trust Fund.

10. Asset Management

- **a.** Peter Daniel gave a report on St. Peter and St. Paul where Esquimalt Council passed approval on 1st and 2nd reading, before negative comments were received from heritage proponents. Over \$200,000 has been spent on predevelopment.
- **b.** Peter reported on the Bethlehem Retreat Centre mortgage refinancing which has been approved by three of the four shareholders, and requires approval from the fourth: The Anglican Synod of the Diocese of BC

That Diocesan Council approves Bethlehem Investors Group Ltd. to refinance under the terms of the Vancity Commitment letter dated 25th July 2018 providing that the negative covenants restricting change of ownership and repayment of shareholder loans are deleted.
