1. Welcome

The Bishop opened the meeting with prayer and thanked the members of Council and Synod staff for their prayers, support and diligent efforts within the Diocese during his recent absence. He shared that it was good to be back and that he would chair the council meeting today.

Faith in Foundation: Asset Management • Financial Resources • Effective Communication • Current Ministries • Shared and Remote Ministries

The Bishop touched on the theme of a Season of Discipleship and how his recent experience with members of his immediate family impacted him, following his father's death. In his family, he saw their natural skills and gifts manifested in caring for his ailing parent. But, beyond this, he experienced the varied spirituals gifts with which each member of his family were blessed. Spiritual gifts are given to each member of our Christian family, in varied ways. As Christians, we are to draw on these gifts, sharing them with those in our church family and with the community beyond the doors of our parish home.

The Bishop extolled the members of Diocesan Council and all Christians to remember that in sharing our spiritual gifts, our actions become "greater than the sum of our parts".

Vision Reflection on a Season of Discipleship - Dean Ansley Tucker

The Dean shared a reading from Romans Chapter 12. She asked the council to consider what we are being asked to do during the Season of Discipleship. How do we share our spiritual gifts and relationships? Table groups discussed what we saw as the gifts we hold within our own person and within our own Christian community. She asked the council members what we are doing well and what we could be doing better as disciples?

The Dean indicated that during the next several months this conversation will continue to grow. She asked Council to remember that "Discipleship is about sending out into the community".

Resolution - Regulation 6.7.01 to Canon 6.7 Subsection e insertion:

Resolved by Diocesan Council that Regulation 6.7.01 to Canon 6.7 of the Canons of the Diocese of British Columbia be amended by inserting the following as subsection e:

e. An elector who is unable to attend a meeting in person may appoint, in writing, another elector to attend and vote on his or her behalf by proxy, provided that no elector may hold more than one proxy at any meeting. A proxy is valid only for the one meeting to which it refers.

Resolved by Diocesan Council that Regulation 6.7.01 to Canon 6.7 of the Canons of the Diocese of British Columbia be amended by inserting the following as subsections f, g, and h:

- f. In a parish with 200 or fewer electors, the quorum for transacting any business at an annual or special meeting of parishioners shall be:
 - i. the incumbent, or, if the incumbency is vacant or the incumbent is absent for any cause, the priest or deacon in charge, if any,
 - ii. at least one churchwarden or deputy warden, and
 - iii. not fewer than ten of the electors of the parish, present in person [or by proxy].
- g. In parishes with over 200 electors, the quorum for transacting any business at an annual or special meeting of parishioners shall be:
 - i. the incumbent, or, if the incumbency is vacant or the incumbent is absent for any cause, the priest or deacon in charge, if any,
 - ii. at least one churchwarden or deputy warden, and
 - iii. not less than ten percent of the electors of the parish, present in person [or by proxy].
- h. If a quorum is present at the start of the transaction of business at a meeting, the meeting is validly constituted and remains so, notwithstanding any reduction in the number of attendees during the course of the meeting.

i. If a quorum is not present within 30 minutes of the time set for the commencement of the meeting, the meeting shall stand adjourned to be resumed at the same time

and place seven days following the date originally set. No further notice of adjournment of the meeting need be given under subsection d.

- j. The electors present at the meeting at which no quorum was present may by simple majority vote choose a different time and place for the adjournment of the meeting, in which case the notice provisions of subsection d. apply.
- k. The incumbent, or, if the incumbency is vacant or the incumbent is absent for any cause, the priest or deacon in charge, if any, at least one churchwarden or deputy warden, the electors in attendance at the time and place fixed for a meeting adjourned under subsection i. or j. shall constitute a quorum.

 - The minutes and resolutions of the vestry meetings and parish council;
 - The parish accounts;
 - The constitution, canons, and regulations of the Diocese, to be retained permanently in the parish, in addition to any other copies required by the incumbent and other officers;
 - An inventory of all church goods and lands.

a) Transforming Futures - Michael Wimmer

The Rev. Michael Wimmer shared with Diocesan council that he has begun the process of visiting with the incumbents, wardens and in some cases the parish councils of every parish. From these visits, it has become apparent that parishes are on a broad spectrum of preparedness toward being ready to proceed with a campaign. There is a need for some further work around what is stewardship and how a campaign will impact a parish. Some of the discussions to date have been very revealing. In all, Transforming Futures is being viewed with many questions. Some parishes see themselves as falling short of being

ready. Michael continues to be positive about this program and is striving to identify those parishes which are ready to proceed.

- Heritage Alteration Process: St. Peter and St. Paul, Esquimalt Three (3) options have been put forward for the connection to the existing heritage-designated church. BC Housing has approved the project. Future dates for the commencement of construction are pending.
- Trinity Church, Port Alberni Upgrades The parish is seeking grants from various sources. A qualified general contractor is to oversee the project.

- Sisters of St. Ann Conditional Offer The conditional offer was not responded to; the offer has lapsed.
- Rectory Upgrades: St. Dunstan, Victoria recommendation from Finance Committee dealt with above.
- Bethlehem Investor Group recommendation from Finance Committee dealt with above.

Canon Ian Alexander reported to Diocesan Council that new guidelines for the Vision Fund will be presented to Diocesan Council in January or February 2019. Following table group discussions, each group reported how they had perceived their own experience with the Vision Fund during the past three years and what they would like to see happen with the fund in the next several years.
