Bishop McMenamie welcomed the members of council to the Parish of All Saints By-the-Sea, Salt Spring Island. Canon Richard Stetson, the Incumbent of the parish welcomed the members of council to the parish hall, gave a short introduction to the parish. 1892 marked the beginning of St. Mark's and 1894 the beginning of St. Mary's. He told the story of the building of All Saints By-the-Sea in the 1990's. Today is the opening ceremonies of the Star of the Sea Spirituality Centre. It is a seen as a home for the community.

1. Bishop's Remarks

The Bishop's written report is on file. He spoke of the Diocesan Year of Reconciliation and has extended the focus until Synod 2018 in April. Bishop Logan spent a little time at this meeting talking about the opportunity he had to travel to the fish farms on the Musgamagw Dzawada'enuxw

Traditional Territory and the statement he made on behalf of the diocese supporting the Musgamagw to revoke the licenses of the fish farms. He has received support in his statement and his stand from the broader church.

2. Vision Reflection/Bible Study

Canon Dawna Wall led the Bible Study on doorways; how do they represent the ways we enter into worship?; have you felt drawn to different styles of worship at various time? A good discussion took place.

The members of council received the news of the death of Canon D. Martin Hendy earlier in the morning. Martin has been very involved in the life of the Diocese of British Columbia as Lay Secretary and a member of many committees and task teams. He was also very involved in the ministries of Christ Church Cathedral which was his home parish. The Bishop offered a prayer of thanksgiving for the life and ministry of Canon Martin Hendy. May he rest in peace and rise with Christ in glory.

3. Living the Vison

a) Liturgical Commission report

Canon Dawna Wall gave an overview of the work of the Liturgical Commission. The Commission was put in place in 2009 by Bishop James Cowan with the beginnings of the Cascadia Liturgy. While much work had been done the members of the commission started moving on to other ministries and so in 2013 the commission was reformed under the direction of Bishop McMenamie. By 2016 if was felt by the people of the diocese the information before them was too much, too complicated and too many options. The commission then offered to simplify things and put together a liturgy for Advent. This was accepted well and the commission was asked to do the same for lent and to include collects etc. that focussed on reconciliation. The next projects include:

- Writing a eucharistic prayer for churches in the urban areas of the Islands and Inlets;
- Constructing a template of the Liturgy of the Islands for ease of use and for consistency of use;
- To find options to distribute liturgical resources in a timely manner.

The National Worship Conference is taking place in Victoria in July 2018. The Dean is the Co-Chair.

4. Faith in Foundation Item #1

The Bishop welcomed back the Venerable Brian Evans who retired from parish life in July and has returned to take the responsibility and role of Stewardship Officer. In this role he joins the executive staff on council. It was pointed out that the Chancellor attended the June council meeting.

f) Report from Provincial Council and COGS

Clara Plamondon spoke to both committees as she represents the Diocese of British Columbia on both.

COGS

Clara is still learning the ropes on this committee. For more information on any of the work of the Anglican Church of Canada you can go to Anglican.ca. The working group on the Marriage Canon has forwarded the work done to the Provincial Groups for consideration.

The members of COGS have come to the considered opinion after much conversation and input that it is not practical to translate the information on the Marriage Canon into local indigenous languages. Translations of other information necessary for the life and ministry of our indigenous brothers and sisters is much more important.

There was a discussion about a living wage for clergy and lay workers in Toronto but the reality is that there needs to be a conversation about a living wage in the church across the country.

There is slow and steady momentum toward self-determination within ACIP.

There was a big discussion about the trafficking of persons. A video can be found at Anglican.ca. Slavery/trafficking in Canada is very real and there is a lot of education that needs to take place.

The conversation continues to take place at the National Church with regards to Ethical Investing.

Clara spoke very briefly about the task force on the provincial newspaper which comes under the direction of the National Communications Committee. There have been conversations and discussion regarding the future of the Anglican Journal and the diocesan newspapers in their current printed form. The first course of action is to survey the members of the House of Bishops and then to hear from the editors and the readership of the newspapers. The process for this is in the early days of preparation.

Provincial Council

The Provincial Council met with the Provincial House of Bishops. The conversations regarding the changing or elimination of diocesan boundaries is now off the table. The more important conversation was about the collaboration with regards to some of the work done in dioceses around finances, youth, locally trained clergy, safe church. etc.

5. Living the Vision #2

a) Thetis Island Task Team Report

Gail Gauthier spoke briefly to the minutes of the Thetis Island task team minutes. The minutes are very detailed to give the members of council a flavor of the discussions that took place at the meeting. The motion put forward will be discussed with the motions from the Finance Committee minutes.

b) We Together Conference Review

Catherine Pate spoke to the conference and to the information gleaned from the evaluation forms. Overall the conference was a great success. As with any event there are areas that could use a little more attention but these will be addressed in the preparation for We Together 2018 which will take place September 28th and 29th. This conference will be held mid-island with the location to be determined. Brenda O'Brien and David Stewart spoke to their experience of the conference. Both enjoyed the conference and meeting new people. The opportunity to hear the theme speakers and gain insight and learnings was a joy.

Some of the information that came out of the conference was the introduction of the Cowichan Camino Walk. This is an opportunity to walk the trail from Duncan to Cowichan Station. This will take place on Saturday October 7^{th} , 2017.

The Salish Centre of Learning is an opportunity for education on the issues that surround us, i.e. dismantling racism, cultural awareness. This will take place in the parish of St. Christopher and St. Aidan, Lake Cowichan, sometime in 2018. This falls under the mandate of Lay Ministry and Leadership Formation.

Back to Jesus Sunday is a time for all parishes to close the physical doors of their church building and gather in the public square in their community. It addresses the often-asked question of "what is God calling you to do and be outside your church buildings"? There is work to be done and more information will follow. This falls under the mandate of Engaging God's World.

Thank you to Catherine Pate for her leadership of the We Together Conference and all the other work she does within the diocese.

c) Canon Committee

Bob Gill spoke to this item. The Canon for the Election of a Bishop needs to be examined and modified. The first draft of that work has been done but has just come into the hands of the members of council. There is a report with the suggested changes to the Canon. This will be discussed further at a meeting either in November or December.

d) Stewardship

Brian Evans and Archdeacon Lon Towstego spoke to their recent trip to Saskatoon to the National Stewardship Conference. They both appreciated the opportunity to affirm what they knew and learned new things in the area of stewardship. These learnings will be shared with the council and the diocese over the next months.

Council broke for lunch at noon and David Chillman said Grace.

The council resumed the meeting at 12.30 and Andrea Davis thanked those who provided us with a wonderful lunch.

6. Faith in Foundation #2

a) Diocesan Council Manual

Tony Davis spoke to this item. The Diocesan Council Manual has been published to provide council members and those considering a place on council with the information they will need to do their job well. With this information individuals can discern whether they are called to sit on the councils of the diocese, and once on council, gives them information to be involved and participate more fully. The suggestion was made that this manual be given to all those who are considering letting their name

stand in nomination for the council which will be elected at the Synod in 2018. There are still some minor additions to the information that needs to be included.

Vision Fund

Vision Fund Jury met on September 14, 2017 to consider eight submissions. One was deferred pending further discussions with the proponent, and another was referred to the Executive Officer for action outside the Vision Fund process. The table below summarizes the jury's recommendations with regard to the other six submissions.

1.	Holy Trinity, North Saanich	Indigenous Perspectives Training	Budget \$9,600	\$7,500 from Vision Fund. Balance from parish (in addition to ~\$2,500 spent earlier in year) – total parish spending of ~\$5,000.
