# 7. Discussion regarding financial assistance to parishes

Following a lengthy discussion, the following recommendation was considered by the Finance Committee.

That Finance Committee recommends to Diocesan Council that a fund, called **The Parish Emergency Relief Fund**, be established to provide emergency financial relief to parishes that are experiencing severe financial difficulties.

The initial phase of the fund will be in the amount of \$200,000 to be sourced from the Vision Fund in the Consolidated Trust Fund. Amounts not exceeding \$10,000 per parish may be awarded to any parish that, in the joint opinion of the Bishop (or Administrator), the Diocesan Executive Officer and Diocesan Finance Officer, is in need of support. The assistance grants shall be non-repayable. Finance Committee and Diocesan Council members will be sent a monthly report on grants made to Parishes.

The Chancellor thanked Bishop Logan McMenamie for his steady leadership of the Diocese of Islands and Inlets (The Diocese of British Columbia) during these past six years. Bob Gill indicated that the bishop will be missed. He wished the bishop "A fair wind and a following sea" as he embarks on the next phase of his ministry and the prospect of being in retirement.

Bishop Logan thanked the members of the Finance Committee for their work on behalf of the Diocese.

John Steele raised several questions regarding the episcopal election process and the recently completed Feasibility Report of the Viability of the Diocese in light of the current COVID-19 pandemic. Bob Gill suggested that the matter be referred to the Episcopal Transition Committee (Planning and Agenda) for further consideration.
