## 6. Dawson Heights Housing Ltd. Annual Financial Statements.

The meeting received the 2018 financials for Dawson Heights Housing Ltd. (DHHL) of which the diocese holds 100% of the shares. The revenue exceeded expenditures by \$320,736. This housing complex is located at the southwest corner of Cedar Hill Road and Cedar Hill X Road in Victoria.

## 7. Asset Management

Peter Daniel presented his information and recommendation about the Christ Church Cathedral Educational Society (CCCES) use of the St. Dunstan Annex. The projected construction cost is \$195,849 with additional paving work for the parking area, or \$141,343 without the additional paving. The soft costs are \$12,500 and the existing debt is \$95,000.

- Confirmation that the lease rental will amortize the funding (principal and interest payments at interest rate of 4%) on terms acceptable to all parties being the parish, diocese and CCCES.

- Confirmation of the lease between the Diocese of BC and CCCES being executed and assigned to the parish
- Confirmation of construction contracts executed between the Diocese and the Contractor.
